discussed, and I suggest to all my hon. friends that they had better wait a few months more when this matter will have been fully examined. Please remember that these questions have aroused great passions and great excitement. I know the feelings in Rajasthan. On the other hand, I am also aware of the feelings that exist in Gujarat. Therefore the question has to be carefully considered and it has to be examined dispassionately. I therefore suggest that this question should be allowed to be considered by the all-India Commission in that dispassionate atmosphere. Otherwise we will have to act in accordance with article 3 of the Constitution.

Written Answers

SHRI H. C. MATHUR: Has the Bombay Government sent any reply or not?

DR. K. N. KATJU: Yes, the Chief Minister has sent a reply.

SHRI H. C. MATHUR: Without referring the matter to the Legislative Assembly?

DR. K. N. KATJU: Certainly he is entitled to do it.

SHRI H. C. MATHUR: Am I to understand that no action is going to he taken by the Government of India under article 3 of the Constitution before receiving recommendations of the Commission which is in the offing?

Dr. K. N. KATJU: I would beg of my hon. friends not to press this question further in the public interests.

SHRI S. MAHANTY: May I ask whether it is a fact that Mt. Abu and the adjoining areas were originally intended to be transferred to Rajas-than, and if so, under what circumstances they were transferred to Bombay?

DR. K. N. KATJU: I do not think that my hon. friend's information is quite correct. I would request my hon. friend not to dissect this question here further on the floor of this House.

SHRI H. C. MATHUR: Will the hon. Minister please let me know whether the Government is going to receive piecemeal proposed recommendations from the Commission or a complete report on the re-alignment of the States throughout the country?
