called High Commissioners prior to Independence. This practice has continued even after Independence. The question of changing this designation to that of Ambassador has been considered at the Commonwealth Conferences. No decision as to a change of designation has yet been arrived at.

## FISSURES IN THE FOUNDATIONS OF THE HIRAKUD MAIN DAM

\*208. SHRI R. BISWASROY: Will the Minister for IRRIGATION AND POWER be pleased to state:

- whether it is a fact (a) that fissures have been detected in the stone foundations of the Hirakud Dam, Main through which water percolates; and
- (b) if so, what steps have taken to stop this percolation?

THE DEPUTY MINISTER FOR IRRI-GATION AND POWER (SHRI J. S. L HATHI): (a) and (b). While preparing the Power Dam foundations this season in the areas not covered during the last working season, certain seams and fissures were noticed in some blocks. These seams and fissures are being treated by the usual methods of foundation treatment; in some cases by blasting away the rock to get down to good rock and in other cases by cleansing, drilling and grouting. These •foundation problems are amenable to treatment.
