

**CLASSIFICATION OF NON-DEVELOPMENTAL EXPENDITURE UNDER REVENUE AND CAJITAL HEADS**

\*183. SHRI P. C. BHANJ DEO: Will the Minister for PLANNING be pleased to state the " procedure adopted in classifying non-developmental expenditure between capital or revenue heads of accounts?

THE DEPUTY MINISTER FOR IRRIGATION AND POWER (SHRI J. S. L. HATHI) : Budgetary procedure does not recognise the distinction between developmental and non-developmental expenditure. Therefore, the question as to the procedure to be adopted for classifying non-developmental expenditure as such between capital or revenue heads of accounts does not arise. The classification of expenditure between revenue and capital heads in Government accounts is determined by rules of allocation as prescribed from time to time in consultation with the Comptroller and Auditor General.
