## INDIANS IN MALAYA, INDO-CHINA AND SINGAPORE

- 183. SHRI M. VALIULLA: Will the PRIME MINISTER be pleased to state:
  - (a) the number of—
    - (i) Indians; and
    - (ii) persons of Indian origin, in Malaya, Indo-China and Singapore;
- (b) how many of them were arrested and detained between 1948 and January 1953 by the Governments of those countries; and
- (c) what happened to the persons who were so detained?

THE DEPUTY MINISTER FOR EX-TERNAL AFFAIRS (SHRI A. K. CHANDA): (a) As estimated on the 30th June 1953, the number of Indians in the Federation of Malaya, Indo-China and Singapore was 6,15,000; 2,000 and 81,400 respectively. There is no hard and fast distinction between Indians and persons of Indian origin.

- (b) Since the beginning of the Emergency in June 1948 up to the 31st January 1953, about 1,390 Indians in the Federation of Malaya and about 109 in the Colony of Singapore were arrested and detained under the Emergency Regulations. No. one was arrested in Indo-China.
- (c) As a result of our representative taking up the matter with high Government officials in Malaya, the cases of the detained persons were reviewed by a Special Committee, and a large number of them released. Further releases are continuing. On the 30th September 1953 there were 111 Indians in Retention in the Federation of Malaya and none in Singapore. Nine Indians were awarded capital punishment of whom five were hanged, one was acquitted and three had their sentences commuted to imprisonment on appeals.
