to Ouestions THE MINISTER FOR REHABILITATION (SHRI A. P. JAIN):

Information in respect oj displaced persons from West Pakistan

(a), (b), (c) and (d). For West Pakistan displaced persons, no new townships are contemplated. Schemes for the provision of about 2 lakh residential units have been or would be sanctioned. When this programme is completed all displaced persons without proper shelter from West Pakistan would be provided for. These displaced persons are living in barracks, dharamsalas or improvised structures on public lands, road-suius, etc.

Information in respect of displaced persons from East Pakistan

- (a) Two schemes for the construction of tenements for displaced persons in Calcutta are under consideration of the Government of India. These tenements, if constructed, are expected to provide accommodation for about 4,400 displaced families.
- (b), (c) and (d). At present there are about 17,300 displaced families in camps in the Eastern States to whom financial assistance in the matter of residential accommodation will be necessary. Information with regard to displaced persons living outside camps is not available.
