#### RESERVATION OF ACCOMMODATION IN TRAINS FROM INTERMEDIATE STATIONS

\*441. SHRI T. D. PUSTAKE: Will the Minister for RAILWAYS be pleased to state whether any steps are being taken to remove the existing ban on reservation of accommodation in trains from intermediate stations; if so, what are these steps?

THE DEPUTY MINISTER FOR RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): Facilities for reservation in 1st and 2nd class from intermediate stations are at present provided in respect of mail, express and some important trains.

It is not possible to provide the facility of reserving seats in 3rd and inter classes from intermediate stations in the present state of traffic.

Arrangements are, however, in existence for reservation of seats in 3rd and inter classes for long distance passengers at train starting stations in respect of important trains. Separate compartments for such passengers are also provided on some trains.

SHRI T. D. PUSTAKE: Does the Government know, Sir, that even if a week's notice is given in advance second class and first class reservations are not being made and no reply is also given?

SHRI O. V. ALAGESAN: If the hon. Member brings any specific case to my attention, I will certainly look into it.
