- (a) whether any survey of the Brahamaputra Valley lor exploration of oil-fields is being carried out; if so, by whom:
- (b) whether the Government of India are in any way connected with this survey;
- (c) whether concessions have been granted to anybody for the exploration of oil in this region; if so. on what terms; and
- (d) what is the nature of the survey operations which are being carried out now and what results have been achieved so far?

THE MINISTER FOR EDUCATION AND NATURAL RESOURCES AND SCIENTIFIC RESEARCH (MAULANA ABUL KALAM .AZAD): (a) and (b). Yes, Sir, the survey is being carried out by the Assam Oil Company Ltd., with the permission of the Government

- (c) Yes, Sir. A prospecting licence for 0:55 square miles has been granted to the Assam Oil Co. Ltd., under the Petroleum Concession Rules, 1949.
- (d) An aeromagnetic survey was started on the 10th December 1953 and is in progress.

A set of general conditions for grants to all-India institutions or societies in the educational, cultural and allied fields is placed on the Table of the House. [See Appendix VI, Annexure No. 160.]
- (c) Grants are paid both in one lump sum and in instalments according to the needs of the institutions.
