- (b) whether Government have any machinery to find out whether the number of blind persons in India is on the increase or on the decrease?

THE DEPUTY MINISTER FOR HOME AFFAIRS (SHRI B. N. DATAR): (a) No. The population figures of blind persons were last available in the 1931 census. The data was found to be inaccurate and no count was, therefore, taken in the 1941 as well as the 1951 censuses.

### SPECIAL CONCESSION TO ASSESSEES IN SOME PART B STATES

296. SHRI M. VALIULLA: Will the Minister for FINANCE be pleased to state:

- (a) whether any special concession is shown to assessees in some Part B States under paragraph 6 of Part B States (Taxation Concessions) Order, 1950;
- (b) if so, what are the reasons for differentiation between one Part B State and another Part B State: and
- (c) what is the estimated loss to the Central Government as a result of this concession to some of the Part B States?

THE DEPUTY MINISTER FOR FINANCE (SHRI M. C. SHAH): (a) In the case of Rajasthan and Madhya Bharat, income of the previous year relevant to the assessment year 1950-51 arising before the first date of April 1949 is not charged to tax, although it is included in the total income for rate purposes.

- (b) The above provision in relation to Raiasthan and Madhva Bharat does not give rise to any differentiation between these two States and other Part B States. While Rajasthan and Madhya Bharat had no state law for the imposition of income-tax, other Part B States had such laws udoer which income arising in these States before the 1st day of April 1949 was anyway chargeable, even if there had been no integration.
- (c) This figure is not available at present and it may take considerable time to obtain it.
