THE MINISTER FOR WORKS, HOUSING AND SUPPLY (SARDAR SWARAN SINGH): (a), (b) and (c). I place on the Table of the House a statement giving the information that is readily available. [See Appendix VI, Annexure No. 175.]

## EXHIBITION OF FILMS IN COMMUNITY PROJECT AREAS

- 309. SHRI M. VALIULLA: Will the Minister for PLANNING be pleased to state:
- (a) whether there is any scheme for the exhibition of films relating to the development programme under the Five Year Plan in Community Project Areas; and
- (b) if so, what is the work done so far in this direction?

THE DEPUTY MINISTER FOB IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) Yes.

(b) From the documentaries produced by the Ministry of Information and Broadcasting, Films Division, 28 documentaries have been selected so far for showing in Community Project Areas. The Ministry of Information and Broadcasting is producing eight documentary films a year for the Community Project Areas. One is ready and the others are in progress. Indents have been placed for two films units. 20 mobile cinema vans. 205 cinema units. and other necessary equipment reauired by State Governments.

## MACHINERY COR PROPAGANDA FOR SALE OF INDIAN TEA

- 310. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:
- (a) what is the machinery employed to do propaganda for the sale of Indian tea in Europe, Canada, South America and Australia; and
- (b) the names of the countries which consume Indian tea?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI): (a) Arrangements for carrying on tea propaganda abroad, following India's withdrawal from the International Tea Market Expansion Boaroy last year, have not I' yet been completed, except in the 'case of the United States of America.

Negotiations for the setting up of joint i Tea Promotion Councils in Canada, Australia and the principal tea consuming countries in Europe, in collaboration with other tea producing countries and the tea trade, are now in progress. At present there are no proposals for doing tea ""propaganda in South America.

(b) Indian tea is exported mainly to the United Kingdom, the United States, Eire. Canada, Australia, Arabia, Iran, the U.S.S.R., Turkey, Chile, Germany, Egypt and Sudan.

# CONSTITUTION OF RAILWAY COLLIERIES UNDER INDIAN COMPANIES ACT

- 311. SHRI M. VALIULLA: Will the Minister for PRODUCTION be pleased to state:
- (a) whether it i<sub>s</sub> proposed to constitute any of the railway collieries as companies under the Indian Companies Act;
  - (b) if so, which are those collieries;
- (c) whether shares will be issued for the public to subscribe; and
- (d) what will be the percentage of Government share in such a company?

THE MINISTER FOR PRODUCTION (SHRI K. C. REDDY): (a) and (b). Whether the future pattern of management of the railway collieries should be by formation of a limited company under the Indian Companies Act or departmentally, as at present, is under the consideration of Government.

(c) and (d). These matters will be considered if and when a decision is taken to form a company. But I may add that it is likely that the shares of such a company when formed will be fully owned by the Government.

### MANUFACTURE OF CIVILIAN EXPLOSIVES

312. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) whether Government propose to set up a factory for the manufacture of explosives for civilian use;

- (c) where it will be located?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI): (a), (b) and (c). Under an agreement signed between the Government of India and Messrs. Imperial Chemical Industries, Ltd., recently, the latter will take steps to set up a factory at Gumia, in Hazaribagh District, Bihar for the manufacture of explosives for civilian use, the Government of India, subscribing Rs. 40 lakhs out of the total authorised capital of Rs. 4 crores.

It is expected that the factory will begin trial production in about 3 years' time.
