SHRI K. C. GEORGE: Of the total amount spent, may I know the exact amount spent on planting and the amount spent on the celebration of the occasion?

Dr. P. S. DESHMUKH: The amount spent is really insignificant. I do not think it comes to more than about one and a half anna per plant. Hardly any expenditure is incurred on mere celebrations out of the tion. amount spent by the Government.

DEMANDS OF THE INSURANCE EMPLOYEES

- *187, SHRI B. V. KAKKILAYA: Will the Minister for Labour be pleased to state:
- (a) whether the All-India Insurance Employees' Association has submitted a charter of demands to Government:
- (b) if so, whether Government will place a copy of this charter on the Table of the Council;
- (c) whether it is a fact that the Chief Labour Commissioner had recently called a conference of the representatives of the insurance employees and employers;
- (d) if the answer to part (c) above be in the affirmative, what discussions took place at the conference and what resolutions were adopted thereat; and
- (e) what action Government propose to take in the matter?

DEPUTY MINISTER THE FOR LABOUR (Shri Abid Ali): (a) and (b). An organisation styling itself as All-India Insurance Employees' Association submitted demands to Government. A copy of the said demands is laid on the Table of the Council. [See Appendix V, Annexure No. 48.]

(c) and (d). The Chief Labour ·Commissioner convened а meeting of representatives of managements and the Association on the 29th June 1953. At that meeting certain tentative conclusions were reached in regard to the procedure to be followed in giving effect to proposals for retrenchment. It was also decided at that meeting that a sub-committee consisting \mathbf{of} representatives managements and the Association the question of should consider scales of pay and allowances and other demands. The sub-committee met in Bombay on the 26th and 27th August 1953 but failed to reach any agreed conclusions.
