SHRI M. VALIULLA: Is it not possible to say whether there is any saving of metallurgical coal or not? say that some steps have been taken. but what is the result?

SHRI O. V. ALAGESAN: It is being saved to the extent that non-metallurgical coal is being used.

SHRI M. VALIULLA: I want to know whether, as a result of the attempts for the last so many years, there has been any saving or not.

SHRI O. V. ALAGESAN: It is being saved to the extent that non-metallurgical coal is being used.

SHRI M. VALIULLA: May I know. Sir, whether the Government have introduced any system of washing of coal so that coal with greater ash content may be used by the introduction of the system of washing?

SHRI O. V. ALAGESAN: We have not introduced such a washing method vet.

SHRI M. VALIULLA: What is the percentage fixed for saving on metallurgical coal per year?

SHRI O. V. ALAGESAN: No percentage has been fixed. I can inform the House that as far as grade II coal is concerned, wherever the sources of the coal supply are near we are using it. When the sources of coal are distant, we use metallurgical coal.

DR. SHRIMATI SEETA PARMA-NAND: Is Government sure that 10 per cent. was not prescribed?

MR. CHAIRMAN: By whom?

Da. SHRIMATI SEETA PARMA-NAND: By the Advisory Committee. by the technical people who went into it. They prescribed 10 per cent, per Is Government sure of this?

SHRI O. V. ALAGESAN: The report of the Railway Fuel Enquiry Committee is under examination.

SHRI B. K. P. SINHA: Is it not a fact that the so-called Railway collieries mostly produce metallurgical coal and that there has been no reduction in their production?

SHRI O. V. ALAGESAN: Yes.

SHRI B. K. P. SINHA: Am I to take it that there has been no reduction in consumption?

SHRI O. V. ALAGESAN: It is not exactly like that. I cannot give the exact figures now.

SHRIMATI M. CHANDRASEKHAR: As given in the statement, they were to make recommendations to the Government of India regarding research schemes and experimental and other programmes relating to family planning to be adopted and the nature and amount of assistance, if any, to be

given to existing voluntary organisations in the field of family planning after a review of their present activities.

DR. P. C. MITRA: May I know whether this will result in the expansion of the span of human life?

MR. CHAIRMAN: When you are trying to protect mothers and children, will it also follow that their lives will be extended as a result of this plan?

SHRIMATI M. CHANDRASEKHAR: Naturally it follows.

Shri GOVINDA REDDY: One of the terms of the Committee, according to the statement laid, is to examine the question of giving assistance to voluntary organisations. May I know if there are any voluntary organisations in the country; and, if so, the number of those organisations, represented in the Committee?

Shrimati M. Chandrasekhar: There are no voluntary organisations represented in the Committee, but one or two members working in voluntary organisations are members of the Committee. But there are many voluntary organisations all over the country working towards this end and they have asked for assistance from Government. So this duty has been entrusted to the Committee to see whether they can be given any assistance.

SHRI B. C. GHOSE: Are any foreign experts associated with it?

MR. CHAIRMAN: No.

Shri B. C. GHOSE: May I know what the foreign population study experts are doing in this country? Has it any relation to this Committee?

MR. CHAIRMAN: Not on this Committee. This Committee does not include foreign experts but he asks why these foreign experts are going about investigating this problem in the country.

Shri B. C. GHOSE: Is there any relation between the two?

Shrimati M. CHANDRASEKHAR: There are two ladies from the W.H.O. who are working in the Family Planning Centres in Ramnagaram as well as in Lodi Colony. They are helping to take the survey at the Family Planning Centres and other than that, they are not giving any other assistance.

SHRI B. C. GHOSE: Is the particular Minister aware that there are certain foreign experts in the country undertaking population studies and have they any relation with this Committee?

SHRIMATI M. CHANDRASEKHAR: Besides those two ladies whom I mentioned, I don't know of any others.
