and Class II officers who have officiated for more than 3 years should be protected to a legitimate extent.

RECLAMATION OF LAND BY THE C.T.O.

*317. Shri B. M. GUPTE: Will the Minister for Food and Agriculture be pleased to state whether it is a fact that 35,000 acres of forest land has been cleared for cultivation by the Central Tractor Organisation?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RAFI AHMAD KIDWAI): Yes, Sir. The exact acreage reclaimed is 36.251.

AMENDMENT OF THE MINIMUM WAGES ACT

- *318. SHRI S. N. MAZUMDAR: Will the Minister for Labour be pleased to state:
- (a) whether Government have received any representation from the Dock labourers' organisations in Calcutta and Bombay regarding the Government's proposal to amend the Minimum Wages Act, 1948; and
- (b) if so, what points have been raised in those representations?

THE MINISTER FOR LABOUR (SHRI V. V. GIRI): (a) Yes. Representations have been received from the Calcutta Port Trust Employees' Association, the Bombay Port Trust General Workers Union and the Dock Mazdoor Union. Calcutta.

- (b) The main requests of the work-
 - (i) that the Minimum Wages Act should be implemented immediately and provisions thereof should be enforced with effect from the 15th March 1951;
 - (ii) that the proposed amendment empowering the appropriate Government to direct that the Act shall not apply to any class of employees in a scheduled employment where on an average the wages payable are Rs. 75 or more per

- month or Rs. 3 or more per day should be withdrawn; and
 - (iii) that the Minimum Wages Act should be extended to cover
 all the categories of workers under the Port Authority (including dock labour) which should be covered but have not been covered so far.

FLYING CLUB FOR GAUHATI

- *319. SHRIMATI PUSHPALATA DAS: Will the Minister for Communications be pleased to state:
- (a) the steps taken by Government to set up a Flying Club at Gauhati;
- (b) the amount of annual subsidy proposed to be given to that club?

THE DEPUTY MINISTER FOR COM-MUNICATIONS (SHRI RAJ BAHADUR): (a) and (b). The Assam Government have been advised to constitute a Club and get it registered. They have also been informed that when this is done. they will be allotted aircraft for training purposes and allowed free operational facilities and hangarage accommodation at Gauhati aerodrome and also granted subsidy on the scale allowed to other Flying Clubs, provided the Club enrolls 100 members and employs necessary instructional and engineering staff. A statement showing the scale on which subsidy is paid at present to Flying Clubs is blaced on the Table.

Statement showing the scale on which subsidy is paid to Flying Clubs

A fixed annual subsidy of rupees thirty thousand payable in four quarterly instalments on and towards meeting the standing charges of the Company. The fixed subsidy is payable quarterly in advance.

Supplementary Flying Bonus.—A sum of Rs. 5 per hour of instructional flying (dual and solo by members) flown by the Company in excess of 1,000 hours per year at the head-quarters of the Company or at the

centre of any satellite club established by the Company and approved by the Central Government in this behalf.

Bonus for Pilots trained.—A bonus of Rs. 250 for each member who qualifies for a Private Pilot's Licence ('A' Licence) and who actually takes out such licence, and a bonus of Rs. 500 for each member who completes a course of Pre-entry training for Civil Aviation Training Centre, Allahabad, and who actually takes out an 'A' Licence.

Hourly Bonus for Flying.—An hourly bonus for flying in respect of those members of the Company who are Indian nationals of not more than 28 years of age at the following rates, namely:—

(a) Members undergoing Pre-entry training for admission to the CATC, Allahabad, on aircraft—

Per hour

- (i) in 65/100 H. P. class Rs. 20. (with effect from 12th January 1950)
- (ii) in 101/129 H. P. class Rs. 22.
- (iii) in 130/185 H. P. class Rs. 25.
- (b) Other members not more than 28 years of age—
 - (i) On aircraft in 65/100 H. P. class. Rs. 15.
 - (ii) On aircraft in 101/29 H. P. class. Rs. 18.
 - (iii) On aircraft in 130/185 H. P. class. Rs. 20.

JORHAT AERODROME

*320. SHRIMATI PUSHPALATA DAS: Will the Minister for COMMUNICATIONS be pleased to state:

- (a) whether the aerodrome at Jorhat has been taken over by the Indian Air Force;
- (b) if not, whether any date has been fixed for this transfer; and
- (c) what arrangements will be available at this aerodrome for the servicing

of aircrafts belonging to the Indian Airlines Corporation after it has been taken over by the Air Force?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR): (a) Yes. The aerodrome has been taken over by the Indian Air Force with effect from the 1st August 1953.

- (b) Does not arise.
- (c) The Indian Air Force have provided the necessary air-traffic control, tele-communication and refuelling facilities at this aerodrome and these facilities are being used by civil aircraft also.

Tourist Information Office for Shillong

*321. SHRIMATI PUSHPALATA DAS: Will the Minister for TRANSPORT be pleased to state whether Government propose to set up a tourist information office at Shillong?

THE DEPUTY MINISTER FOR RAIL-WAYS AND TRANSPORT (SHRI O. V. ALAGESAN): Not at present, Sir, but Government are making certain enquiries in the matter.

SUGAR FACTORIES IN BIHAR.

- †*215. Dr. P. C. MITRA: Will the Minister for FOOD AND AGRICULTURE be pleased to state:
- (a) the number and location of sugar factories in Bihar; and
- (b) the quantity of cane and gatecane crushed by each of those factories during the years 1951-52 and 1952-53?
