THE MINISTER FOR HEALTH (RAJKUMARI AMRIT KAUR): (a), (b) and (c). Four schemes were received from Himachal Pradesh Government during 1952-53; they are 'Nahan', "Mandi', "Theog' and 'Jogindernagar' Water Supply Schemes and the dates of receipt are 2nd January, 12th January, 16th February and 20th February 1953 respectively. No scheme has been received during the year 1953-54. These schemes were lacking in technical details and are still under scrutiny in consultation with the Himachal Pradesh Government.

- (d) No funds have been provided for the current year and, therefore, the progress of these schemes has been held up for the time being. However, the Government of India will make every effort to provide for necessary expenditure from the existing Revenue grant to the Himachal, Pradesn Government.
- (e) Yes; three villages have deposited their share of the expenditure.
