LOANS FOR IRRIGATION AND POWER PURPOSES

- 151. SHRI P. C. BHANJ DEO: Will the Minister for Finance be pleased to state:
- (a) the amount of loans granted for the irrigation and power schemes of State Governments from the Special Development Fund set up from the sale proceeds of American wheat loan up to date;
  - (b) the balance in the Fund;
- (c) the estimated recoveries during 1953-54 of irrigation and other loans granted in the past; and
- (d) the rate of interest on irrigation loans granted from this Fund?

THE MINISTER FOR FINANCE (SHRI C. D. DESHMUKH): (a) About Rs. 25 crores.

- (b) About Rs. 45.5 crores.
- (c) No recoveries are due during 1953-54 on account of the principal amount of loans advanced. Recoveries during 1953-54 will be of only interest.
- (d) The rate of interest varies from  $3\frac{1}{2}$  per cent. to  $4\frac{1}{4}$  per cent. per annum depending on the period of the loan and the interest rates which prevailed at the time the loans were sanctioned.

## DISPOSAL OF APPEALS BY THE BUREAU OF MINES

- 152. SHRI R. G. AGARWALA: Will the Minister for Natural Resources and Scientific Research be pleased to state:
- (a) how many cases of appeals were received annually by the Bureau of Mines under Section 57 of the Mineral Concession Rules, 1949, from different States from the year 1949 to 1952 statewise:
- (b) how many cases of appeals have been disposed of annually by the

Bureau of Mines from the year 1949 to 1952; and

(c) how many cases have been dismissed by the Bureau of Mines and how many cases have been decided in favour of the appellants from the year 1949 to 1952, year by year?

THE MINISTER FOR EDUCATION AND NATURAL RESOURCES AND SCIENTIFIC RESEARCH (MAULANA ABUL KALAM AZAD): (a) to (c). Appeals under Rule 57 of the Mineral Concession Rules 1949 lie with the Government of India in the Ministry of Natural Resources and Scientific Research and not the Indian Bureau of Mines.
