

(d) The installed capacity of the power station is 80,000 K.Ws. This power station is used to supply the daily consumption of electric power and process steam required by the factory. The station also supplies part of its power to the Damodar Valley Corporation.

IMPORT AND MANUFACTURE OF UMBRELLA CLOTH

34. **SHRI M. VALIULLA:** Will the Minister for COMMERCE AND INDUSTRY be pleased to state:

(a) what is the annual requirement of umbrella cloth in India;

(b) whether any mills in India are manufacturing this cloth; and

(c) what is the quantity and value of this cloth imported in the year 1952-53?

THE MINISTER FOR COMMERCE (SHRI D. P. KARMARKAR): (a) 14.4 million yards.

(b) Yes.

(c) Licences were issued to the value of Rs. 34,45,524.

EXPORT OF MATCH BOXES AND MATCH STICKS

35. **SHRI M. VALIULLA:** Will the Minister for COMMERCE AND INDUSTRY be pleased to state the names of the countries to which India exports match boxes and match sticks?

THE MINISTER FOR COMMERCE (SHRI D. P. KARMARKAR): Ceylon and Pakistan.

CELEBRATION OF INDIA-AMERICA WEEK

36. **SHRI M. VALIULLA:** Will the PRIME MINISTER be pleased to state;

(a) the number of Americans who participated in the India-America Week celebrations held in April 1953 at New York;

(b) what was the programme for each day; and

(c) whether similar celebrations took place in any other country?

THE PRIME MINISTER AND MINISTER FOR EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) About 400 Americans attended every evening. At times visitors had to go away for want of room.

(b) There were speeches and panel discussions on Indian philosophy and literature; demonstrations of Indian dancing; exhibition of Indian documentary films, including one on Mahatma Gandhi; and an exhibition of Indian paintings and other objects of art.

(c) Our Missions in other countries also arrange such cultural functions from time to time.

INCOME FROM CENTRAL GOVERNMENT PROPERTIES ON HILL STATIONS

37. **SHRI M. VALIULLA:** Will the Minister for WORKS, HOUSING AND SUPPLY be pleased to state the income derived by Government from their properties at hill stations?

THE MINISTER FOR WORKS, HOUSING AND SUPPLY (SARDAR SWARAN SINGH): The annual income derived by Government in respect of buildings maintained by the C.P.W.D. at hill stations is about rupees seven lakhs and sixty-four thousands. A major part of this income comprises of rent for the residential accommodation; a large share of the office accommodation available at these places is occupied by service departments from whom no rent is recovered.

EXPORT OF COAL

38. **SHRI M. VALIULLA:** Will the Minister for PRODUCTION be pleased to state:

(a) whether any firm has approached Government for the grant of facilities to export coal;

(b) if so, what are those firms and what action Government have taken in the matter, and

(c) whether there is any ban on the export of coal to any country in the world?

THE MINISTER FOR PRODUCTION
(SHRI K C REDDY) (a) Yes.

(b) Messrs Binnis Mercantile Company, Limited, Calcutta, and Messrs Bird & Company, Limited, Calcutta, asked for the abolition of the additional (commercial) charge on coal exports in order to make Indian coal prices competitive in foreign markets. This question had already been under the consideration of the Government and a decision was taken to abolish the commercial charge with effect from 11th May 1953. In addition, Messrs Associated Agencies, a new firm, asked for permission to offer 80,000 tons to Japan. The permission was not granted by the Coal Commissioner as the firm had neither any colliery nor any experience in coal export. Messrs Ram Saran Das & Bros. have just applied for export of 5,000 tons of coal to Japan and the matter is under consideration.

(c) There is no ban on the export of coal to any country except South Africa.

EXPORT OF RUBBER

39 SHRI M VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state the quantity and value of rubber purchased from India by the United Kingdom, Ceylon, Canada, France and the United States of America during the last three years?

THE MINISTER FOR COMMERCE
(SHRI D P KARMARKAR). A statement is attached [See Appendix V, Annexure No 8].

EXPORT OF SALT

40. SHRI M. VALIULLA: Will the Minister for PRODUCTION be pleased to state.

(a) the names of the countries which are competing with India in the sale of salt to Japan, Pakistan and Nepal,

(b) whether there are any other countries to which India is exporting salt,

(c) whether there is any custom duty levied on the export of salt, and

(d) which are the countries in the world which import salt?

THE MINISTER FOR PRODUCTION
(SHRI K C REDDY). (a) According to the information available with Government, Spain, Italy, Middle East countries and Aden are competing with India in exporting salt to Japan, and Pakistan is no longer importing salt from any other country. In regard to exports of salt from India to Nepal, there is no competition.

(b) Salt is also exported to Burma and Maldiv Islands and some other countries, but the quantities are negligible.

(c) No.

(d) The information is not readily available.

(b) whether the South Indian match companies have made any representations regarding the difficulties experienced by them in obtaining the raw materials for the manufacture of matches if so what action Government propose to take in the matter; and

(c) whether it is a fact that the competition by the Western India Match Company has greatly affected
