DR. P. C. MITRA: Is it a fact that the Bihar Assembly has passed a resolution to the effect that the bridge to connect South Bihar with North Bihar be constructed at Patna instead of at Mokameh, and that resolution has been forwarded to the Government of India for consideration?

SHRI O. V. ALAGESAN: All that was taken into consideration by the Ganga Bridge Committee presided over by Shri M. Visvesvaraya who recommended Mokameh site.

SHRI B. K. P. SINHA: Are Government aware that the sentiment in "Bihar is, better have a bridge at Mokameh than have no bridge at all?

(No reply.)

SHRI K. B. LALL: May I know if Government received representations from the Government of Bihar as well as the public I and was lying at various railway regarding having the bridge at Patna rather than at Mokameh?

SHRI O. V. ALAGESAN: Because there was a difference of opinion, the matter was referred to the Visvesvaraya Committee for expert opinion, and they decided that a bridge at Mokameh site was preferable to a bridge at Patna site.

SHRI K. B. LALL: May I know if it is a fact that during the investigations there was controversy and there was difference of opinion among the experts themselves?

(No reply.)

SHRI B. RATH: What is the distance between Mokameh and Patna?

SHRI O. V. ALAGESAN: I have no idea.

KHWAJA INAIT ULLAH: About 100 miles.

DR. D. H. VARIAVA: When is the bridge likely to be ready?

SHRI O. V. ALAGESAN: During the Railway Budget discussion the hon. Member must have noticed that provision has been made for starting the work.

THE MINISTER FOR HEALTH (RA.T-KUMARI AMRIT KAUR): Yes, in connection with the establishment of an All-India Medical Institute.

SHRI H. C. MATHUR: May I know, Sir, whether it had been decided to build the All-India Medical Institute In the compound of the Irwin Hospital?

RAJKUMARI AMRIT KAUR: Sir. a site of 200 acres has been allotted to us in the neighbourhood of Safdarjang area. There is no question of building the All-India Medical Institute in the compound of the Irwin Hospital.

SHRI H. C. MATHUR: Is it a fact that the foundation stone was laid by the New Zealand Minister' within the premises of the Irwin Hospital?

RAJKUMARI AMRIT KAUR: It is true that the foundation stone was laid in the neighbourhood of the Irwin Hospital because the original scheme was that the All-India Medical Institute should be established with the Irwin Hospital as its nucleus, but since then we have decided to move the All-India Medical Institute to the Safdarjang area. 2-3 C.S.D.

RAJKUMARI AMRIT KAUR: To the extent of one crore and a quarter.
