ENFORCEMENT OF MINIMUM WAGES ACT

*160. SHRI V. K. DHAGE (on behalf of Dr. R. B. Gour): Will the Minister for LABOUR be pleased to state:

- (a) the industries to which the Minimum Wages Act has been ap plied, State-wise; and
- (b) the industries which the to Act has not yet been applied and the reasons therefor?

THE DEPUTY MINISTER FOR LABOUR (SHRI ABID ALI): (a) and (b). The attention of the hon. Member is invited to the statement laid by me a few minutes back in reply to question No. 152. It will be observed therefrom that minimum wages have not been fixed in certain employments in Part 'B' States. This is because the Act was made applicable to them only with effect from the 1st April 1951. Further, as minimum wages could not be fixed after the 31st March 1952, in the case of some States the process of fixing minimum wages was not completed by the above date.

SHRI C. G. K. REDDY: Some of the industries which have been omitted have been only of Part B States, or is an industry like mining completely omitted all over the country?

SHRI ABID ALI: Sir, this Minimum Vages Act has been applied to some nines in some States.

SHRI B. B. SHARMA: May I know what would be the approximate price of the trip of this gentleman who has gone for synthetic rice, and the cost of the machinery that is purchased?

SHRIMATI M. CHANDRASEKHAR: If he asks about any particular scheme, I will be able to reply.

SHRI V. K. DHAGE: What is the extent of "partly financed"?

SHRIMATI M. CHANDRASEKHAR: Sir, the question was asked whether any of the public health schemes is assisted by the World Health Organisation. Wherever assistance has been given by the W.H.O.. it has been indicated in the statement. Where no assistance has been given by the W.H.O., that also has been indicated in the answer.

MR. CHAIRMAN: The rest of it is financed by the Government of India

SHRI V. K. DHAGE: In the statement under 'Family Planning' I find that two field workers have been provided by the W.H.O. to assist in the population studies conducted under the scheme at Ramanagaram (Mysore State) and New Delhi. Sir, May I know what are the qualifications of these two field workers and what does the "scheme at Ramanagaram" mean?

RAJKUMARI AMRIT KAUR: The qualifications of these two workers are that they have conducted experiments in this particular field before they came here. A visit to Ramanagaram will show what is actually being done there. A sum of Rs. 3 lakhs has been provided by the Central Government for 1952-53 and there are units in New Delhi also. If hon. Members would go and see what is being done there, they would get a clear grasp of the work done there.

SHRI V. K. DHAGE: Under the scheme for a Nursing Project in Calcutta, it is stated that four nurses have been provided by the W.H.O. May I know what is the nature of the work of these four nurses under the Nursing Project

SHRIMATI M. CHANDRASEKHAR: I did not follow the question.

MR. CHAIRMAN: He has passed on to the Nursing Scheme from Family Planning. He asks; What are the qualifications of the four nurses sent by the W.H.O. and how are they fitted for this particular job?

SHRIMATI M, CHANDRASEKHAR: There are four nurses. One is a Tutor Sister in Nursing Education. The second is a Tutor Sister specialising in Paediatric Nursing. The third is a Tutor Sister specialising in Nursing Arts, and the fourth is a Tutor Sister specialising in Midwifery (Lecture Room and Wards).

SHRI V. K. DHAGE: How many fellowships have been provided under this scheme and what is the amount?

SHRIMATI M. CHANDRASEKHAR: If the hon. Member puts a separate question. I will be able to give him the answer.

SHRI B. RATH: There is a family planning project in Ramnad in Mysore State. What is the density of the population there?

MR. CHAIRMAN: It is not Ramnad. It is Ramanagaram.

SHRI B. RATH: What is the density of the population there?

INDIAN DOCTORS FOR TRAINING ABROAD

- (a) whether some Indian doctors have been selected for research work and specialised training in foreign countries under the auspices of the World Health Organisation; and
- (b) if so, (i) the names of these doctors; (ii) the countries to which they are going; and (iii) their respective subjects of study?

THE DEPUTY MINISTER FOR HEALTH (SHRIMATI M. CHANDRASE-KHAR): (a) Yes; the scheme of World

Health Organisation fellowships for higher training abroad in medical and allied subjects has been in force since 1949,

(b) A statement giving the information in resoect of the 1952 fellowships is laid on the Table of the House. *[See*

Appendix IV, Annexure No. 62.]

SHRI V. K. DHAGE: Has any doctor been sent for any research work?

SHRIMATI M. CHANDRASEKHAR: Whatever materials were wanted have been given in the statement.

SHRI V. K. DHAGE: The question was whether any doctors had been sent to foreign countries for research and specialised training under the auspices of the W.H.O. I do not find any reference in the statement supplied to me of any one having gone in for research studies.

RAJKUMARI AMRIT KAUR: The list that has been given is for a particular year. The subjects for which the fellowships have been given are indicated. Whether any fellowships have been given for doing research only, I cannot give you the list of names here today.

SHRI V. K. DHAGE: Has any doctor been sent abroad to study T.B. Visiting Homes?

RAJKUMARI AMRIT KAUR: There are any number of specialists in the line in our own country.

SHRI K. C. GEORGE: May I know whether any of these doctors are doing researches in elephantiasis?

RAJKUMARI AMRIT KAUR: At the moment, No, Sir. Anyhow, we are doing researches in our own country.

SHRI K. C. GEORGE: May I know whether the hon. Minister is aware mat a large number of people in the •Dastal regions in our country are p.iitfering from this disease? MR. CHAIRMAN: Surely.

SHRI K. B. LALL: Sir, I want to refer to the way in which answers are being given in the House. When a question is put by a questioner, the answer is that a statement is laid on the Table, and we do not know what the answer is. Unless the answer is very voluminous, I think that the answer should be read
