

PROF. G. RANGA: That will do, agreed, agreed.

SHRI J. R. KAPOOR: Is there any arrangement in Himachal Pradesh for the preservation of these potatoes in cold storage and if not, do the Central Government propose to give financial assistance to the Himachal Pradesh Government to establish one big cold storage where the potatoes can be preserved?

SHRI M. V. KRISHNAPPA: That is perhaps the major idea of the Himachal Pradesh Government. They are introducing a Bill in their Assembly and they are taking up special powers so that they may be able to organise the whole thing in a proper manner and we are prepared to give them any help either financially or otherwise.

SHRI C. L. VARMA: Is the Government aware that the potato growers of Himachal Pradesh received the highest price for their Phoot and Ration potatoes last year?

SHRI M. V. KRISHNAPPA: Yes. They receive Rs. 20 per maund whereas they used to get Rs. 5 to Rs. 6 earlier.

POST AND TELEGRAPH GUIDE

*588. SHRI S. M. HEMROM: Will the Minister for COMMUNICATIONS be pleased to state:

(a) whether the Post and Telegraph Guide is published annually, and, if not, what is the year of its latest issue;

(b) whether all the Post Offices are provided with the latest issue of the Guide; and, if so, what is the number of copies so supplied; and

(c) how many copies of the Guide were sold to the public in the year 1952-53?

THE DEPUTY MINISTER FOR COMMUNICATIONS (SHRI RAJ BAHADUR) : (a) Till 1946 the P. & T. Guide was being published annually. Since then it has been brought out once in two

years. The latest edition is that of June 1952. Part I of that edition has been published, but Part II is still under print.

(b) Yes, to all Head and Sub-Post Offices whose number on 31st March 1953 was 8,623.

(c) Number of copies sold to the public in 1952-53:

Part I	...	2,479
Part II	...	1,415

SHRI T. V. KAMALASWAMY: What is the cost for each guide?

SHRI RAJ BAHADUR: I cannot give it from memory. The total cost to the Department comes to Rs. 2 lakhs.

PROF. G. RANGA: Sale price per copy?

SHRI RAJ BAHADUR: I don't know the sale price per copy. The total cost to the Department is Rs. 2 lakhs.-

SHRI S. M. HEMROM: Is it a fact that even the Delhi Post Offices are using the 1950 editions still?

SHRI RAJ BAHADUR: They use the edition which has been published recently in June 1952. Part II is still under print and so they must be using the 1950 edition for Part II.

SHRI KISHEN CHAND: Is it a fact that due to the issue of these tickets there has been a lot of congestion in the third class compartments?

SHRI O. V. ALAGESAN: In some cases it is so.

SHRI KISHEN CHAND: Is it fair to the travelling public which pays full fares to be inconvenienced by the issue of these tickets?

SHRI O. V. ALAGESAN: It is rather a difficult question. We were asked to issue these concession tickets. This House itself was demanding the issue of these tickets and when they are issued, some congestion is inevitable. To relieve the congestion we are also adding more coaches.

SHRI KISHEN CHAND: The House demanded a reduction in fares. L
