SHRI B. C. GHOSE: Are they only 5 berth coaches or are they 4 berth coaches?

SHRI O. V. ALAGESAN: I don't have the information here.

SHRI B. C. GHOSE: What are the new facilities that the Minister said are being provided in the new second class coaches?

SHRI O. V. ALAGESAN: I have not said that new facilities are being provided. The coaches are there and can be seen. The width of the seat was a little less than before and that question is now being reviewed.
