### ORAL ANSWERS TO QUESTIONS

#### FUNDS FOR HEALTH SERVICES

- \*22. SHRI K. C. GEORGE: Will the Minister for HEALTH be pleased to \*state:
- (a) whether the Delhi State Government have represented that more funds should be made available to them for Health Services under the Five Year Plan;
- (b) whether any other States have made similar representations; if so, -which are those States; and
- (c) what steps have been, or are proposed to be. taken by Government in the matter?

THE DEPUTY MINISTER FOR HEALTH (SHRIMATI M. CHANDRASE-KHAR): (a) The Delhi State Government have made a representation to the Planning Commission that more medical and public health schemes should be included in the State's Five Year Plan. The matter is under the consideration of the Commission.

SHRI K. C. GEORGE: Has the Government of Travancore and Cochin made any representation?

SHRIMATI M. CHANDRASEKHAR: Not for health.

# INTERNATIONAL CONFERENCE ON CHILD WELFARE

- \*23. SHRI K. C. GEORGE: Will the Minister for HEALTH be pleased to state:
- (a) whether it is a fact that *Hu* International Conference on Child Welfare was recently held in Bombay;
- (b) if so, by whom was the Conference sponsored, by which countries delegates were sent to it and by whom India was represented thereat:
- (c) what were the proposals made at the Conference by the Indian delegates; and
- (d) what was the outcome of this Conference?

THE DEPUTY MINISTER FOR HEALTH (SHRIMATI M. CHANDRASE-KHAR): (a) An International Study Conference on Child Welfare was held at Bombay from the 5th to 12th December, 1952.

- (b) It was convened by the International Union for Child Welfare, Geneva, at the invitation of the All India Save the Children Committee which has since been merged into the Indian Council for Child Welfare. A list of the countries, organisations, etc. who sent delegates to the Conference is laid on the Table of the House. The Government of India was represented by Dr. (Mrs.) Sharyu Bhatia, Adviser in Maternity and Child Welfare, Directorate General of Health Services.
- (c) The delegates were not expected to make proposals on their own but

were required to attach themselves to one or other of the Study Groups and the Group as a whole made recommendations to the Conference.

SHRI V. K. DHAGE: Has the Go^ eminent under contemplation a mod Children's Act as recommended By tl Child Welfare Conference?

RAJKUMARI AMRIT KAUR: A mod Children's Act is under the contempl; tion of the Government of India.

DR. D. H. VARIAVA: May I knoi whether the resolutions passed by thi Conference have been distribute amongst the Health Departments of the different States in India?

SHRIMATI M. CHANDRASEKHAR I am not aware

DR. D. H. VARIAVA: Would it no be desirable to distribute these resolu tions amongst the State Government; so that wider publicity is given to thesi resolutions and the States who wan to make an improvement in the healtl of the children can take advantage o: these suggestions?

RAJKUMARI AMRIT KAUR: Thi Conference was not a Governmenta' Conference. Therefore Government cannot take any action in the matter. The Organisations who called the Conference were at liberty to send these Resolutions to all Governments. Presumably, this has been done

SHRI K. C. GEORGE: On page 5 of the Resolutions it is mentioned that clothing for children up to five years should be reduced to the minimum, that clothing should be simple, loose and sufficient enough only to keep the child warm. Has this Conference considered the case of children having no clothing at all?

Mr. CHAIRMAN: The question does not arise. Those who have clothes must have loose clothes.

### TELEPHONE RENTALS IN MYSORE STATE

- \*24. SHRI M. VALIULLA: Will the Minister for COMMUNICATIONS be pleased to state:
- (a) whether Government are aware of the resolutions regarding telephone charges passed at a public meeting under the auspices of the Journalists' Association, Mysore, on the 23rd December, 1952; and
- (b) whether a deputation waited on the Minister for Communications in the first week of January, 1953 at Bangalore to seek redress against the enhancement of the telephone rentals?

THE DEPUTY MINISTER FO» COM-MUNICATIONS (SHRI RAJ BAHADUR):

- (a) Yes.
- (b) Yes.

SHRI M. VALIULLA: Is it not a fact that the telephone rentals were very much cheaper in Mysore State before the integration?

SHRI RAJ BAHADUR: It is a fact that the rentals were lower than those obtaining in other parts of the country.

SHRI M. VALIULLA: Have the trunk telephone charges been raised from Re. -/12/-to Rs. 2/2/-?

SHRI RAJ BAHADUR: Yes, to bring about uniform rates throughout the country.

SHRI M. VALIULLA: Is it necessary that the same rates should prevail in ail places, whether big or small?

SHRI RAJ BAHADUR: It is a necessary corollary of financial integration that there should be uniform tariffs throughout the country.

SHRI M. VALIULLA: Did the Journalists' Association, Mysore, make a representation to the Minister for Communications to lower the rates?

SHRI RAJ BAHADUR: Yes, Sir. Their representation was that Bangalore should not be treated in the same way as the big commercial centres like Bombay, Madras and Calcutta, but H.M. replied that he had also to consider towns like taluk headquarters which were far smaller than Bangalore where also the same rentals are being recovered in order to ensure uniformity.

SHRI M. VALIULLA: After that, have you thought over the matter?

SHRI RAJ BAHADUR: I have already replied.

SHRI B. K. MUKERJEE: Is it a fact that the Government recently separated the administration of the telephone and telegraph sections and thereby increased the administrative cost of the telephones?

SHRI RAJ BAHADUR: Neither does it arise from the question, nor is it a fact.

SHRI B. K. MUKERJEE: Does the Government consider that the telephone is an essential system of communication to the community?

SHRI RAJ BAHADUR: Obviously, it is very essential.

SHRI B. K. MUKERJEE: Can the Government say that under the present telephone tariff telephone facilities are available to the common man in this country?

SHRI RAJ BAHADUR: The rates are not high.

SHRI D. D. ITALIA: Are trunk telephone facilities available in all the districts of Hyderabad?

MR. CHAIRMAN: From Bangalore we are now going to Hyderabad. We may be going to other places too.
