SHRI D. NARAYAN: What was the production during those years?

Dr. P. S. DESHMUKH: I have got the production figures. For the year 1949-50, it was 591.36 million lbs., in 1950-51 it was 589 million lbs. and for 1951-52, 504 million lbs.

SHRI D. NARAYAN: How much of land is under cultivation of tobacco?

DR. P. S. DESHMUKH: I would like to have notice for that question, Sir.

SHRI D. NARAYAN: What are the approximate requirements of tobacco in India?

Dr. P. S. DESHMUKH: I have no figures to show the requirements but the consumption is given here. I believe most of the requirements of the country are met, Sir.

SHRI D. NARAYAN: Is not tobacco imported from outside?

KHWAJA INAIT ULLAH: Only in the shape of cigarettes.

DR. P. S. DESHMUKH: That will have to be addressed to the Minister for Commerce and Industry.

SHRI B. M. GUPTA: How much tobacco is used in biri making and how much for chewing?

- SHRI D. NARAYAN: How much is used for cigars?
- DR P. S. DESHMUKH: I have no information.
- SHRI D. D. ITALIA: May I know, Sir, if any quantity of tobacco is exported from India to outside?
  - MR. CHAIRMAN: That has been stated.
- \* DR. P. S. DESHMUKH: Yes Sir. That has been stated.
- SHRI M. VALIULLA: What is the price for export?
- DR. P. S. DESHMUKH: Prices vary from time to time.
  - SHRI M. VALIULLA: For 1952?
- DR. P. S. DESHMUKH: I have not got the figures.
- DR. SHRIMATI SEETA PARMANAND: Is the Government aware that other countries are processing potatoes in a particular manner before planting and using those leaves for blending with tobacco?
- DR. P. S. DESHMUKH: I have no information.
- SHRI M. P. N. SINHA: Is Bihar one •f the main producers of tobacco?
- DR. P. S. DESHMUKH: Sir, this question refers to consumption and export.
- SHRI M. P. N. SINHA-: Are Government aware that due to the conditions prevailing, the area under cultivation of tobacco has been considerably reduced in the State of Bihar during the last two years?
- Dr. P. S. DESHMUKH: I have not got the information here, Sir.

SHRI M. P. N. SINHA: Do Government know that on account of heavy duty people have given up cultivation of tobacco in the State of Bihar?

- DH. P. S. DESHMUKH: I submit, Sir, that it does not arise out of this and I am not expected to carry all these information.
- SHRI K. L. NARAS1MHAM: How much is exported by the I.L.T.D. Company?
  - MR. CHAIRMAN: That is a detail.
- DR. P. S. DESHMUKH: I have not got the information.
- SHRI B. V. KAKKILAYA: Are the Government aware that the *biri* and cigarette industries find it difficult to get tobacco?
- DR. P. S. DESHMUKH: We have not had any complaints.
- SHRI S. N. MAZUMDAR: Has not the Government received representations from the biri makers all over the country drawing its attention to this matter?
  - DR. P. S. DESHMUKH: No. Sir.
- SHRI D. NARAYAN: Do our Cigarette Factories use only Indian tobacco?
- DR. P. S. DESHMUKH: A very large portion of the Indian tobacco is used, Sir.
- SHRI D. NARAYAN: What percentage, Sir?
- Dr. P. S. DESHMUKH: I could not say. Sir.
- SHRI R. P. N. SINHA: Does the hon. Minister use tobacco. Sir?
- DR. P. S. DESHMUKH: In very small quantity, Sir.
