there is no bar as I said; if the person is found fit, he is granted an extension and in that case it does become pensionable but I may also add that in other cases gratuity is given, which is quite considerable.

SHRI C. G. K. REDDY: The question, I think, is if the extension is granted, whether the entire period is counted as continuous service?

SARDAR S. S. MAJITHIA: Yes. naturally, if extension is granted.

REGIONAL AUTONOMY FOR LADAKH

*493. SHRI S. MAHANTY: Will the Minister for States be pleased to state whether Kushak Bakula, the Buddhist leader of Ladakh has made any representation to the Government of India claiming regional autonomy for Ladakh?

THE MINISTER FOR HOME AFFAIRS AND STATES (DR. K. N. KATJU): The Government of India received in December 1951 a copy of a representation the subject on addressed to the Chairman. Basic Principles Committee of the Jammu and Kashmir Constituent Assembly.

SHRI S. MAHANTY: What steps the Government of India have taken on the representations of the Head Lama of Ladakh?

Dr. K. N. KATJU: The representation is a matter primarily for the Jammu and Kashmir State and I am certain that the State Constituent Assembly and their Basic Principles Committee will give it their most adequate consideration.

- *494. SHRI D. NARAYAN: Will the Minister for Education be pleased to state:
- (a) whether Government will lay on the Table of the Council the proceedings of the Seminar held in Delhi to study the contribution of Gandhian outlook and technique to the solution of tensions within and between nations;
- (b) how many delegates attended the Seminar and to which countries they belonged; and
- (c) what are the recommendations made by the Seminar to further its objectives?

THE MINISTER FOR EDUCATION RESOURCES AND NATURALSCIENTIFIC RESEARCH (MAULANA ABUL KALAM AZAD): (a) A copy of the proceedings when published will be supplied to the Library of the Parliament.

- (b) Sixteen delegates attended the Seminar from the countries of U.K., U.S.A., Brazil, Japan, Italy, Egypt, Iran, Germany, France and India.
- (c) A statement is laid on Table of the Council.

STATEMENT

Recommendations of the Semithe 'Contribution of Gandhian Outlook and Techniaues to the Solution of Tensions between and within Nations'.

The main recommendations of the Seminar are as follows:-

The participants were agreed that only by the application of Gandhian principles, world peace can be preserved and national and international tensions can be resolved. The fear hatred that now poison the nations can be relations between effectively counteracted by Gandhian outlook and techniques. The Seminar expressed its faith in

the United Nations and hoped that SCIENTIFIC RESEARCH consistent with the Gandhian principles, it should be both universal in its membership and work on the basis of non-violence in international disputes. It also recommended that all technical and other assistance for the under-developed areas should be canalized through the United Nations and its Specialized Agencies so as to avoid exploitation or domination of one nation by another. The Seminar was opposed to the division of the world into two rival blocs and was generally of the opinion that a front of peace-loving nations should be built so as to provide a moral equivalent to war and prevail upon the rival blocs to arrest the drift towards a world catastrophe. Seminar stressed the need for reorientating educational systems on lines with a view to Gandhian eradicating various national and racial prejudices.

The Seminar recommended that Ministry or Unesco should the publish a small brochure embodying maior recommendations conclusions of the Seminar, which should be prepared by Professor Humayun Kabir. The Seminar also recommended that a volume entitled 'Gandhi and Peace' should be published containing statements by the participants.
