INDIAN LABOURERS IN GOA

VIOLET ALVA: *501. SHRIMATI Will the PRIME MINISTER be pleased to state the total number of Indian labourers employed in the mining industry in Goa?

THE PARLIAMENTARY SECRE-TARY TO THE PRIME MINISTER (SHRIMATI LAKSHMI MENON): About 8.000.

SHRIMATI VIOLET ALVA: Is it a fact that the labourers are unable to make remittances to India owing to lack of exchange facilities?

SHRIMATI LAKSHMI MENON: Normally there are no difficulties about remittances of money from Goa to Recently, however the Baneo Nacional has not been releasing the necessary exchange; not because they do not have the necessary money in their coffers but due to other causes.

SHRIMATI VIOLET ALVA: Is it a fact that because of this hardship the money-lenders are now charging as much as half to one per cent.?

SHRIMATI LAKSHMI MENON: Government are not aware.

SHRIMATI VIOLET ALVA: Is it a fact that the mining trade in Goa is mostly in Indian hands?

SHRIMATI LAKSHMI MENON: Yes; the mines are run by Indian business concerns; 90 per cent. of the capital is of Indian origin and 50 per cent. of labour is also Indian.

SHRIMATI VIOLET ALVA: Is it a fact that the Goa authorities were concerned about this lack of exchange facilities and they have been in communication with the Government of India on this matter?

SHRIMATI LAKSHMI MENON: No. Sir.

SHRI C. G. K. REDDY: The hon. Minister said there were other reasons

SHRI J. S. L. HATHI: That is a pro- ' for this lack of exchange facilities. Have the Government any idea of these other reasons and if so, may I know what they are?

> SHRIMATI LAKSHMI MENON: Normally speaking.....

> SHRIMATI LAKSHMI MENON: Time alone will show.

SHRI C. G. K. REDDY: Pardon?

Mr. CHAIRMAN: Patience is advised.

SHRIMATI VIOLET ALVA: Has the Portuguese State Bank of.....

Thereupon the Government of India withdrew permission for the Portuguese banks operating in Bombay and. I believe, gave them notice. I do not but these factors also have to be borne in mind.

TRAINING INSTITUTIONS FOR WELFARE Work

- *502. SHRIMATI SHOILA BALA DAS: Will the Minister for Planning be pleased to state:
- (a) whether a sum of rupees 4 crores has been provided in the Five Year Plan for social welfare activities; if so, how this sum has been used or is proposed to be used;
- (b) how many new training institutions for social welfare work are proposed to be set up by the State Governments; and
- (c) whether there are any such institutions in existence at present in any of the States, if so, in which of the States?

THE DEPUTY MINISTER FOR PLANNING & IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) Yes. A social welfare board, which will be shortly constituted, will administer the Fund.

- (b) State plans do not provide for new training institutions for welfare work.
- (c) Schools of social work, which are assisted by Government, exist at Bombay, Baroda, Madras and Delhi. At 25 Extension Training Centres, situated in various States (as mentioned in the statement attached), village level workers receive training in rural welfare work. In addition, there are also some special training courses for social workers such as those conducted by the Madras Government, the Kasturba Trust and others. [See Appendix IV, Annexure No. 123.]
- . SHRIMATI SHOILA BALA DAS: Is a quota fixed for any State?

- SHRI J. S. L. HATHI: No quota is fixed.
- SHRI S. MAHANTY: May I know know exactly when the notice expires; whether any curriculum has been drawn up for these rural welfare training centres?
 - Shri J. S. L. HATHI: There is a curriculum and it will be modified in the light of experience.
 - Prof. G. RANGA: Will any contributions be made to the institutions that are being run under the Kasturba Trust?
 - SHRI J. S. L. HATHI: I think this will be taken into consideration by the Board.

SHRI K. C. GEORGE: May I know from the hon. Minister, whether it is proposed to get down any foreign expert or foreign persons for this pur-
