THE DEPUTY MINISTER FOR RAIL-WAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) No. The deficit in the Hooghly Pilotage Account was fully met from the General Account in 1951-52.

SHRI O. V. ALAGESAN: Yes, the deficit started from 1950-51 and it is continuing.

SHRI M. VALIULLA: What was the deficit in 1950-51?

SHRI O. V. ALAGESAN: Rs. 10,43,068.

SHRI M. VALIULLA: How was it met?

SHRI O. V. ALAGESAN: It was met partly from the General Account and partly from the Revenue Reserve and Vessels Replacement Fund.

SHRI M. VALIULLA: Under what rules?

SHRI O. V. ALAGESAN: Under section 9 of the Calcutta Port Pilotage Act, 1948.

SHRI M. VALIULLA: Is it not a fact that the amount can only be taken from the General Fund?

SHRI O. V. ALAGESAN: This amount was taken from that Fund.

SHRI M. VALIULLAH: As per the report given by Government, the amount could be taken only from the General Fund. May I know what is the amount at the credit of the Vessels Replacement Fund?

SHRI O. V. ALAGESAN: It is nil. The entire amount has been withdrawn.

SHRI M. VALIULLA: What is the likely deficit in the present year?

SHRI O. V. ALAGESAN: 1952-53 deficit is estimated to be Rs. 915,900.

SHRI M. VALIULLA: How is it likely to be met?

SHRI O. V. ALAGESAN: From General Account.

SHRI M. VALIULLA: What is the position of the General Account?

MR. CHAIRMAN: I want to tell you that you started with 1951-52 went back to 1950-51 and now you are going to 1952-53, and all this circulation with the idea

SHRI M. VALIULLA: The idea is if the deficit is about 9 or 10 lakhs there should be some method found out to see that it does not arise.

MR. CHAIRMAN: When they have the deficit, they will discover how best it will be met but it is a hypothetical question.

SHRI M. VALIULLA: It is chronic. It is going on.

SHRI C. G. K. REDDY: Would the hon. Minister let us know whether this Pilotage revenue is from Pilotage only or is also from the Harbour Masters' Fees.

SHRI O. V. ALAGESAN: I have no information. I would like to have notice.

SHRI C. G. K. REDDY: Would he let us know how the rate for pilotage in Calcutta port which, more or less, is for piloting for about 120 miles, com pares with pilotage charges in other parts of the world and if it is very low, as I understand it is very low......

MR. CHAIRMAN: It does not arise out of this. He says the deficit in Hooghly Pilotage account and you are asking for the rates of pilotage.

SHRI C. G. K. REDDY: It does arise. I would submit that the revenue is low because the rate is low.

MR. CHAIRMAN: Put a different question.
