hon. Member puts a separate question. I will certainly be glad to answer it.

SHRI GOVINDA REDDY: The hon. Minister, Sir, may give an jdea of what it is. I do not know the rules.

DR. B. V. KESKAR: I said that he gets certain facilities in the matte\* of getting information from the various Ministries of the Government of India and if is not possible for me'to enumerate the facilities.  $\blacksquare$ 

SHRI GOVINDA REDDY: I quite-concede that, Sir. May I know how many accredited representatives to the headquarters of the Government of India are there?

DR. B. V. KESKAR: I am afraid, I would not be able to give the exact number. The number is more than 120 at present.

SHRI GOVINDA REDDY: May 1 know, Sir, if the representatives accredited to the State Governments can become accredited to the headquarters of the Central Government?

DR. B. V. KESKAR: Provided they stay in Delhi.

SHRI G. RAJAGOPALAN: Inasmuch as the press representatives in "the various State capitals are doing the same work as accredited correspondent's here, why should not this concession be extended to them also? What is the reason that they are not given this concession and it is only given in Delhi?

DR. B. V. KESKAR: Sir, there is no ban on representatives accredited State to Governments being given any such concession. The question is, first of all a number of State Governments do not have accreditation system as we have here. Secondly, it is a question between the State Governments and the Railway Ministry, because the concessions are not given by us. Wc recommend to the Railway Ministry and, probably the State Governments can arrange it with the Railway Ministry.
