#### HONORARIUM PAID FOR PROGRAMMES FROM RADIO STATIONS

\*149 SHRIMATI CHANDRAVATI LAKHANPAL: Will the Minister for INFORMATION AND BROADCASTING be pleased to state:

(a) the amount of money paid as honorarium during the current and last financial years for the programmes in English and in Hindi separately broadcasting from the following stations of the All India Radio—

- (i) Delhi;
- (ii) Jullundur;
- (iii) Lucknow; and
- (iv) Allahabad;

(b) whether Government are considering any proposal to (i) increase the proportion of Hindi Programmes; and (ii) raise the standard of payment?

THE MINISTER FOR INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) The information is being collected and will be placed on the Table of the Council in due course.

(b) There is no fixed proportion for Hindi broadcasts. Our general policy is to increase the proportion of Indian language broadcasts wherever possible.

#### EXPORT VALUE OF FISH

14. SHRI E. K. IMBICHIBAVA: Will the Minister for COMMERCE AND INDUSTRY be pleased to state the value of fish exported from the West Coast, separately for Travancore-Cochin, Malabar and the Ponnani Taluk of Malabar District, during the year 1951-52?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI): Statistics of export are recorded according to the ports from which the goods have been shipped to foreign countries and not according to their places of origin. The value of export of fish during 1951-52 from Cochin and other ports in South India is given in the table below:

cheroots and the duty realised on these according to the sea borne trade accounts during 1951-52 was Rs. 15,886.

#### BAN ON THE IMPORT OF BROKEN GLASS

(a) whether there is at present a ban on the import of broken glass into India from Ceylon, Pondichery and Karaikal;

(b) whether the South Indian Glass Manufacturers Association have represented to Government to lift the ban; and

(c) if so, what steps Government propose to take in the matter?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI): (a) Yes, Sir. The import of broken glass is banned from all sources.

#### ASSISTANCE TO THE SERICULTURAL INDUSTRY

18. SHRI M. VALIULLA: Will the Minister for COMMERCE AND INDUSTRY be pleased to State the steps taken by Government to assist the Indian sericultural industry since 1952?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI T. T. KRISHNAMACHARI): Tariff Protection to the sericulture Industry has been extended upto 31st December 1953. The Central Silk Board which has been set up by the Government of India for assisting and developing the sericulture industry in India was re-organised and put under the administrative control of the Textile Commissioner to the Government of India who has been appointed as the Board's Vice-Chairman. The Government of India have also approved of various schemes and grants-in-aid proposed by the Boards for development of sericulture industry in various States. The schemes include the establishment of Regional Sericultural Research Stations in Madras, Mysore, West Bengal and Assam as also other development schemes in the States of Assam, West Bengal, Madras, Mysore, Uttar Pradesh, Punjab and Himachal Pradesh.

(a) how many press delegations from foreign countries have come to India during the last three years at the invitation of Government;
