- (b) and (c). The following release benefits were authorised for the demobbed personnel:—
- (i) Leave as admissible under the Mysore State rules, subject to a maximum of 24 months; and also subject to the condition that such leave does not extend beyond the age of superannuation.
- (ii) Travelling allowance as admissible under State rules for individuals and their families.
- (iii) Pension and gratuity admissible under the following alternatives, whichever was more favourable:—
 - (A) Mustering out pension/ gratuity admissible under the Mysore State rules;
 - (B) Special scales of mustering out pension/gratuity authorised by the Government of India;
 - (C) Mustering out pension/ gratuity to J.C.Os. O.Rs. only at rates corresponding to I.A. scales of these awards.
- (d) Pension takes effect from the date following that of discharge of the released individual.
- (e) and (f). Out of 969 individuals eligible for pension, payments have been authorised in 867 cases, leaving a balance of 102 claims in respect of which titles are under verification.
