According to article 240, Parliament may enact laws for Part C States. By that the President has been given power to rule Part C States and everything done by the President with regard to Part C States is done under the authority of Parliament given in the Part C States Act passed in the year 1951. In other words, the relevant articles in the Constitution are 239 and 240. The Constitution leaves it to Parliament to make laws for the governance of Part C States. All the provisions of the Constitution do not apply to Part C States. The provisions of the Constitution relating to union Parliament and legislature of Part A and B States do not apply to Part C States. There is a separate Act known as the Part C States Act, 1951 which defines the constitution, functions and powers of the legislature.

SHRI V. K. DHAGE (Hyderabad): May I just interrupt? May I know whether the other provisions of the Constitution apply to Part C Sates?

SHRI K. S. HEGDE: Part VI applies to Part C States, not all the articles of the Constitution.

SHRI GULSHER AHMED: This is so because the framers of the Constitution thought that these areas were small, and the level of Administration there was not up to the mark. That is the reason why they created a third kind of States in the Constitution. So, all the provisions of the Constitution are not applicable to Part C States. So far as Part C States are concerned, they have left everything under articles 239 and 240 to Parliament to decide the future form of Government.

MR. DEPUTY CHAIRMAN: The hon. Member may continue tomorrow.

SHRI K. S. HEGDE: Is it not necessary, Sir, to have an afternoon session?

SHRI H. N. KUNZRU: Not necessary.

SHRI C. G. K. zz: Tomorrow it is extended till 12—30.
