

FOOD SCARCITY IN SOUTH INDIA

85. SHRI M. VALIULLA: Will the Minister for FINANCE be pleased to state:

(a) whether an Investigation Committee was set up to tour parts of South India and to report on the famine and food scarcity conditions prevailing there;

(b) if the answer to part (a) above be in the affirmative, what are the findings of that Committee; and

(c) what action has been taken by Government in the matter?

THE MINISTER FOR FINANCE (SHRI C. D. DESHMUKH) : (a). No Investigation Committee has been set up, but a team of Central Government officers headed by Shri P. C. Bhattacharyya was sent to Rayala-seerna area of Madras to study the situation on the spot.

(b) and (c). The recommendations of the team are under consideration and a statement on the action taken will be laid on the Table of the House in due course.
