## STRIKE AT HINDUSTAN SHIPYARD

SHRI S. N. MAZUMDAR (West Bengal): Sir, the other day there were references about the strike at the Hindustan Shipvard in both the Houses and the Prime Minister also made some statement the other day on the floor of the House. This morning I navreceived a telegram from Vizag to the effect that the workers there are asking for immediate reinstatement pending the decision of the Tribunal. The strike is continuing and there was complete hartal and a procession of 20,000 people went round. So, Sir, I would like to have some statement made by the Leader of the House or by any Government spokesman as regards the demands of the workers.

THE LEADER OF THE COUNCIL (SHRI C. C. BISWAS): I did not have notice of this proposal and so I am not fully posted with the facts of the case. Beyond the statement which was made by the Prime Minister in the other House, I have no further statement to make at the present moment. If so desired, I may obtain further information and then enlighten the House about it.
