## POWER PRODUCTON

- 5. SHRI M. VALIULLA: Will the Minister for PLANNING be pleased to state
- (a) whether it is a fact that according to the draft outline of the Five I Year Plan published in July 1951, the irrigation and power projects undertaken by the Central Government (namely, Bhakra, Nangal, Harike, Damodar Valley and Hirakud) were expected to produce 933,000 k.w. of power, and that according to the revised draft plan, the production is expected to be have to inform hon. Members tha I have about 541,000 k.w. of power or even less and
- (b) if so, what are the reasons for this huge fall in the estimate of power production?

THE MINISTER FOR PLANNING. IRRIGATION AND **POWER** (SHRI GULZARILAL NANDA): (a) Yes, Sir.

(b) The difference is due to a postponement of the installation of power units at Bhakra Dam and the Hirakud project.
