THE DEPUTY MINISTER RAILWAYS AND TRANSPORT (SHRI O. V. ALAGESAN): (a) Though the narrow gauge line between old Siliguri Station and Siliguri Junction constitutes some limitation widening and improvement of road and does not carry any passenger traffic these days, its retention is considered necessary by the West Bengal Government as well as the Railway Administration, as it continues to serve as an efficient and cheap means of transport for foodgrains from the State Government godowns from Siliguri Town to different areas of the deficit district of Darjeeling.

- (b) As very few trains run over this rail-road bridge, it can hardly be said to inconvenience the public.
- SHRI S. N. MAZUMDAR: Is the Minister aware that there is another line, a metre gauge one running from Siliguri Junction to and through Siliguri Town?
- SHRI O. V. ALAGESAN: I am not aware, Sir.
- SHRI S. N. MAZUMDAR: Will the Minister please note?
- DR. RADHA KUMUD MOOKER-JI: This is a live railway line and I don't know how it could have escaped the attention of the Minister.
- SHRI O. V. ALAGESAN: I may not know the various railway lines running in the country, Sir.
- SHRI S. N. MAZUMDAR: May I know, Sir, under whose administration this road-cum-rail bridge is? Who is responsible for this bridge?

SHRI O. V. ALAGESAN: I am afraid, I shall have to ask for notice.
