the Council to the fact that we are meeting today, on the anniversary of a fateful day, a day in the history of the world; for today is the Fourteenth of July, the date of the Storming of the Bastille, an epoch-making event which has stood for ages as the symbol of the liberation of the oppressed peoples of the world against age-long autocracy. May I be permitted to suggest that your honoured self as Chairman of the Council of States of the Republic of India, do convey to the President and the Parliament of the Republic France our fraternal greetings on this day, the Independence Day of France, and that you do further convey to them the assurance that the inspiring ideals of liberty, equality and fraternity proclaimed a century and a half ago on the banks of the Seine have lost none of their appeals even today to us sitting here on the banks of the Yamuna.

THE LEADER OF THE COUNCIL (SHRI N. GOPALASWAMI) : Mr. Chairman, the day of the storming of the Bastille is certainly a famous day in the world's history. But I respectfully submit that so far as the proceedings of this Council are concerned, it seems rather incongruous that we should pay any particular attention to that day. We have had our own Independence Day, and let us respect it, and let us honour its We certainly do pay homage to those people who stormed the Bastille and established the great principles of liberty, equality and fraternity. But I suggest that the Council is not the place for referring to it or for doing anything for the purpose of celebrating it.
