Conference on Letters

*7. SHRI R. B. SINHA: Will the Minister for Education be pleased to state:

- (a) what recommendations made by the Conference on Letters called by the Government of Ind.: in the year 1951; and
- (b) what steps the Government have taken to implement them?

THE MINISTER FOR EDUCATION (Maulana ABUL KALAM (a) The hon. Member's attention is drawn to the Report of the Conference on Letters, dopies of which are available in the Parliament Library. [Placed in Library. See No. IV G.O. (53)]

(b) The draft constitution of a National Academy of Letters prepared by a committee appointed in accordance with the recommendation of the Conference is under consideration.
