VISIT BY THE INTERNATIONAL STUDY GROUP OF INLAND WATERWAYS.

- 23. SHRI M. VALIULLA : Will the MINISTER FOR RAILWAYS AND TRANSPORT be pleased to state :
- (a) the names of places in India visited by the International Study Group of Inland Waterways;
- (b) whether the Government of India have accepted the recommendations of the Study Group; and
- (c) what was the expense that India incurred on the visit of the Study Group?

THE MINISTER FOR RAILWAYS AND TRANSPORT (SHRI LAL BAHADUR; : (a) During their short stay of three days in India, the Study Group of Inland Water Transport experts visited the Port of Calcutta where they inspected inland steamer ghats and the repair and docking facilities of the Joint Steamer Companies. They also made short trips on the Hooghly river and through the navigation canals in the area.

- (b) The Study Group has only submitted an interim report to the ECAFE a copy of which has been received. The final report is awaited.
- (c) The entire expenditure on the tour, excepting for a sum of Rs. 3,700 on account of the travelling allowances of the experts from India to Bangkok and back, was borne by the Technical Assistance Administration of the United Nations Organisation.

- (a) whether it is a fact that the Pakistan Government has requested the Government of India to give her some quantity of wheat; and
- (b) if so, what decision has the Go vernment of India taken on this re quest?]

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI RAFI AHMED KIDWAI): (a) and (b). Yes. In view of the Pakistan Government's urgent need for wheat, the Government of India have communicated to that Government their willingness to arrange diversion of two cargoes of wheat which are due to arrive at an Indian port, the transaction to be so arranged that replacement for us will be on a 'no profit no loose' basis.
