(c) whether Government have received any representation from the Indian Lamp Factories Association of over production in the electric lamps industry, and the action the Government propose to take in the matter ?

THE DEPUTY MINISTER FOR COMMERCE AND INDUSTRY (SHRI D. P. KARMARKAR): (a) A statement showing the capacity and production in 1951 of the different units is attached. *\See* Appendix I, Annexure No. 15.]

(b) A new unit has been sanctioned (with 22% capital subscribed by U. K. firms) which has undertaken to manufacture intricate components, not produced in India at present, required for the manufacture of g. 1. s. lamps. The output of the firm has been restricted to 6 million lamps a year.

(c) Yes. The matter is under consideration.

A statement showing the quantity for which permits were issued by the Coal Commissioner to the various consumers in U. P., excluding supplies to the Railways, during 1951 and the first four months of 1952, is laid on the Table of the House. The statement also shows the despatch figures. *[See* Appendix I, Annexure No. 16.]

(fc) Coal supplies to U.P. are arranged exclusively from the Bengal/ Bihar fields. A statement is laid on the Table of the House showing the wagon allotment for these fields during 1951 and the first four months of 1952. *[See* Appendix I, Annexure No. 17.]
