SHRI LAL BAHADUR: We have not yet started the work. It is proposed to be started in 1954-55.

SHRI M. VALIULLA: How. much do you intend spending in 1954-55?

SHRI LAL BAHADUR: I am sorry I shall require notice.

SHRI GOVINDA REDDY: Will the hon. Minister assure us that top priority will be given to this project?

SHR LAL BAHADUR: I cannot s ly top priority but we are giving priority to this project but we do not expect that it will be completed earlier than perhaps 1956-57.

SHRI C. G. K. REDDY: Does this mean that the proposed Hassan-Mysore link will be abandoned or has been abandoned?

SHRI LAL BAHADUR: Why should it be abandoned?

SHRI C. G. K. REDDY: Because such a big priority has been given to the other project, will this also be taken up?

SHRI M. VALIULLA: Is there a Board of Management to control these funds?

RAJKUMARI AMRIT KAUR: These funds are at the disposal of the Minister of Health and the Ministry of Finance is always tsken into consultation.

SHRI M. VALIULLA: Is it a permanent grant or does it vary according to needs?

RAJKUMARI AMRIT KAUR: So far at my special request it is being given every year.

SHRI M. VALIULLA: Do you call for applications to give the grants?

RAJKUMARI AMRIT KAUR: No, Sir. I do not call for applications. But I am already flooded by applications.

SHRI M. VALIULLA: Has it been brought TO vour notice that the Government of Cochin and Mysore have not been given a single pie?

RAJKUMARI AMRIT KAUR: Probably they did not apply.

BEGAM AIZAZ RASUL : Do the Government receive reports from these organisations and institutions as to how these funds were being used and are the Government satisfied that the funds are properly used?

RAJKUMARI AMRIT KAUR; Not a single pie is given to any institution unless audited accounts are supplied to us and unless we are assured by the Government of th; S-.ate or by the organisations sponsoring the

appeal that the money will be properly spent.

SHRI K. C. GEORGE: May I know the types of voluntary organisations to which these funds are given?

RAJKUMARI AMRIT KAUR: Well, for example, the Ramakrishna Mission which do a very great deal of good work. There are other institutions like the Chittaranjan Cancer Hospital in Calcutta. There are institutions that are doing leprosy work. 3 For example there is a very fine leprosy clinic recently started at Amraoti in Madhya Pradesh and there are some Mission Hospitals and institutions that are doing good work for T.B. and other diseases.

BEGAM AIZAZ RASUL: Is priority given to those organisations which deal with women and children's diseases and their requirements?

RAJKUMARI AMRIT KAUR: No priority is given. Grants are made according to the work, the calibre of the work and the needs of the organisation concerned.

CREDIT FACILITIES TO PUBLISHERS FOR CARRIAGE OF NEWSPAPER PARCELS

*64-A. SHRI C. G. K. REDDY: Will the Minister for RAILWAYS be pleased to state:

- (a) whether credit facilities are allowed to publishers for the carriage of newspaper parcels over the Railways;

- (e) No. Credit facilities have, however, been withdrawn from 'Dinasari' of Madras and 'Hindustan Newspapers Limited' of Bombay for continuing to default in payment.

SHRI C. G. K REDDY: Sir, I asked in part (e) whether publishers enjoying credit facilities still owe large sums of money.

SHRI LAL BAHADUR: I have said that as the payments due were eventually made, there is nothing in arrears now.

SHRI C. G. K. REDDY: Is it possible for the hon. Minister to lay a statement on the Table to let us know which publisher owes how much?

SHRI LAL BAHADUR: There are no arrears. But if the hon. Member wants and if he can kindly come to me, I can give him the figures.
