### STATEMENT

Translation of Basic Sanskrit Works in other Indian Languages

(a) and (b) There is no comprehensive plan at present to bring out translations of basic Sanskrit works in other Indian languages. Grants -ire, however, being paid to Voluntary Sanskrit Organisations *inter-alia* for bringing out translations of basic Sanskrit texts in Hindi and other Indian languages. As regards, enrichment of vocabulary of Indian languages, the Commission for Scientific and Technical Terminology is already seized of the problem. In order that the maximum possible uniformity in all Indian languages may

be ensured, about 60% to 70% of the terms finalised by the Commission are based on Sanskrit roots.

- (c) 98 cases have been registered by the S. P. E. against the firms/persons, of which one has ended in conviction, 2 are under trial, 6 arc pending departmental action and 8£ are pending investigation.
