pleased to state:

(a) whether it is a fact that Gov-  
ernment are considering a proposal to  
shift the Indian Air Force Flying College  
from Jodhpur to a place near Hyderabad;

(b) if so, what are the main con-  
siderations for this shifting;

THE DEPUTY MINISTER IN THE  
MINISTRY OF DEFENCE (DR. D. S.  
RAJU): (a) A proposal is under  
consideration.

(b) The institution should be located  
at a place where the training programme  
will not be disrupted during emergency  
by being vulnerable to enemy attacks. It  
is also considered desirable to provide all  
stages of training at one place.

(c) The college is proposed to be  
shifted under temporary arrangements by  
August 1966. The new training institution  
is planned to start functioning at its new  
location from 1968-69.

(d) The non-recurring expenditure  
is estimated at Rs. 12 crores.

SHRI M. C. SHAH: May I know whether this idea of shifting the centre has anything to do with the recent bombing of Jodhpur by Pakistan?

SHRI Y. B. CHAVAN: No, Sir.

SHRI M. C. SHAH: May I know whether this centre is expected to work as an integrated academy for the Air Force with a view to providing basic as well as defence training?

DR. D. S. RAJU: Yes, Sir.

**श्री विमलकुमार मन्नालालजी चौरड़िया:**  
क्या श्रीमान यह बतलाएंगे कि वर्तमान में जोधपुर के निवासियों पर वहां से यह ट्रेनिंग सेंटर हटाने का मनोवैज्ञानिक असर न पड़े इस दृष्टि से अभी इसको स्थगित रख कर और भविष्य में जब पूर्ण शान्ति हो जाय उस समय इसको हटाने का विचार किया जाय इसके बारे में शासन का क्या दृष्टिकोण है ?

SHRI Y. B. CHAVAN: Both the things have nothing to do with each other. Certainly, we have taken some additional steps which would provide better air defence facilities in Jodhpur. Even in order to do that, this training centre will have to be shifted because really speaking, that place cannot be a place where these two types of operations can be done. And then again, even in the interests of the emergency, you cannot afford to suspend the training activities for any indefinite period. It is for this purpose that you will have to have it at the other place. This proposal is not something of recent origin, this was going on and this was being examined for a long time past and this Air Academy was being thought of for sometime now. Now, it has been accepted in principle to start it.

SHRI BIREN ROY: The hon'ble Deputy Minister said that temporary measures are being taken. Why should we not make it permanent in Hyderabad which is strategically the best position?

DR. D. S. RAJU: The information that the hon. Member got is not correct. This is what I said in reply to part (c):

"The college is proposed to be shifted under temporary arrangements by August 1966."

SHRI BIREN ROY: Why not permanent?

SHRI Y. B. CHAVAN: May I explain, Sir? The hon. Member has misunderstood the word "temporary arrangements". The shifting is permanent. The arrangement that will be made will be temporary.

**श्री जगन्नाथ प्रसाद :** श्रीमान्, हाल ही में पाकिस्तानी आक्रमण के कारण जोधपुर में हुई बमबारी की वजह से और राजस्थान की सीमा पर सशस्त्र आक्रमण की वजह से आपका ध्यान इस ओर आकृष्ट हुआ कि जोधपुर से एकादमी को हटा कर हैदराबाद ले जाया जाय। तो क्या जोधपुर में इसी तरह की कोई दूसरी चीज हो जो वहां के लोगों के लिए लाभदायक सिद्ध हो सकती है, खोलने की व्यवस्था करेंगे ?

SHRI Y. B. CHAVAN: Really speaking, Jodhpur is better arranged for air defence. It will be taken care of. This question of having this training institute certainly is some sort of handicap for providing necessary training.
