Bill to control expenditure and food wastage in marriages

3449. SHR1 AVINASH PANDE : Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) whether Government is planning to come up with a legislation to control the profligate expenditure and huge food wastage in marriages and other social events; and

(b) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (PROF. K.V. THOMAS) : (a) and (b) There is no plan at present to come up with a legislation to control the profligate expenditure and huge food wastage in marriages and other social events. However, the Central Government has set up a Committee under the Chairmanship of Secretary of the Department of Consumer Affairs to study the various aspects of food wastages witnessed especially during occasions like marriages/parties/meetings in the country and suggest ways and means to control it.

Additional foodgrains to poor districts

†3450. SHRI JAI PRAKASH: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) whether the Central Government has taken any steps to provide additional foodgrains and also foodgrains for work in the poorest districts of Uttar Pradesh, according to the directions of the Supreme Court;

(b) if so, the details thereof;

(c) whether the Central Government itself has urged the State Government for taking steps to again identify the families below the poverty line and for collecting data in this regard; and

(d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (PROF. K.V. THOMAS) : (a) to (d) The Government of India has made adhoc additional allocation of 5 million tons of foodgrains to all States and Union Territories for distribution to Below Poverty Line (BPL) families at BPL prices, in May 2011. Uttar Pradesh has been made an additional allocation of 546,122 MTs of rice and 272,758 MTs of wheat.

In pursuance of the orders of the Hon'ble Supreme Court dated 14.5.2011 to reserve 5 million tons of foodgrains for distribution to the 150 poorest districts or the extremely poor and vulnerable
