Shortfall in targets set for social healthcare schemes

3628. SHRIMATI T. RATNA BAI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether investment in social healthcare schemes will fall short of the targets set out in the Eleventh Five Year Plan;
- (b) if so, the details thereof and the reasons therefor especially in schemes implemented in Andhra Pradesh; and
 - (c) the steps being taken to avoid such situation in future?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) to (c) As against the planned Central allocation of Rs. 1,40,135 crore, for Health sector during the Eleventh Plan (2007-2012), the actual allocation of funds from 2007-08 to 2011-12 has been Rs. 99,491 crore. Out of this, allocation for National Rural Health Mission (NRHM) has been Rs. 70030 crore as against the planned allocation of Rs. 90558 crore for the Eleventh Five Year Plan. Funds are released to the States including Andhra Pradesh, both under NRHM as well as under other specific schemes, depending on the availability of resources and progress made in the implementation of the schemes. Ministry of Health and Family Welfare regularly pursues with Planning Commission for enhancement in the annual allocation of resources for health sector.

Upgradation of medical colleges

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) and (b) The Government is implementing Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) which also envisages upgradation of existing Government medical college institutions in various parts of the country, to improve health infrastructure through construction of Super Speciality Block/Trauma Centre etc. and procurement/installation of medical equipment for existing as well as new facilities.

Central Government also has a scheme for strengthening and upgradation of State Government medical colleges by way of one time grant of Rs.1350 Crores under a new Centrally Sponsored Scheme (CSS) with funding pattern of 75% by Central Government and 25% by State Government for starting new Post Graduate disciplines and increasing PG seats.

(c) and (d) Yes. The details of the proposals of State Government considered under the above schemes are given in statement.
