**Shelter for patients and attendants at AIIMS**

†\*475. SHRI SHREEGOPAL VYAS: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government is aware of the fact that people coming for treatment at the most prestigious Government Institute, AIIMS, have to bide their time on roads and on footpaths, and patients and their relatives are compelled to spend a number of days under the open sky for the sake of their treatment; and

(b) if so, the efforts being made by Government to provide shelter to these patients and their relatives?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) and (b) AIIMS has three dharamshalas with a capacity of around

430 beds for the benefit of outstation patients and their attendants. However, given the heavy influx of patients to AIIMS from all over the country, the existing facility is proving to be inadequate. Six AIIMS like institutions are currently under development in various parts of the country. Once these become operational, the pressure on AIIMS, Delhi, is expected to reduce.

#### **Inclusion of Rajiv Aarogyasri under NRHM**

\*476.SHRI MOHD. ALI KHAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the State Government of Andhra Pradesh has requested the Ministry to include the Rajiv Aarogyasri under National Rural Health Mission (NRHM) by bearing some financial expenditure; and

(b) if so, the details thereof and the action taken so far?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) and (b) Yes, Sir. The State Government of Andhra Pradesh has requested the Government for providing financial support to the Rajiv Aarogyasri Health Insurance Scheme under National Rural Health Mission (NRHM).

This Ministry is of the view that since Aarogyasri Scheme deals with tertiary care and is not in consonance with the objectives of National Rural Health Mission (NRHM), which focuses on strengthening of primary and secondary health care in the public sector, the funding for the same would not be possible under the NRHM.

However, a token support of Rs.10 crore each in 2007-08 and 2008-09 had been provided under NRHM for this Scheme as an innovative measure.
