

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY) : (a) to (c) There have been no studies in the country to suggest that rates of depression have increased among youth. There are also no long term prospective studies on trends of hypertension among Indians.

A meta-analysis of cross sectional Indian studies on prevalence of hypertension indicates that there has been a significant increase in hypertension in both urban and rural areas. There is sufficient clinical and epidemiological evidence that hypertension is increasing in India. Increasing hypertension in India and other developing countries has been related to sedentary lifestyle, excess dietary salt, calorie and alcohol intake, increasing generalized and central obesity, stress of migration and urbanization.

National Mental Health Programme is providing treatment and counseling services to all mental disorders/illnesses including depression under its District Mental Health Programme component.

Role of ASHAs in JSY

*479.SHRI AVINASH PANDE: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the role of ASHAs in achieving the target of 100 per cent institutional delivery under the Janani Suraksha Yojana (JSY);
- (b) the amount of funds allocated under JSY since its inception in 2005, State-wise;
- (c) the number of pregnancy cases covered by the scheme in the last five financial years;
- (d) whether Government has estimated the number of cases of unattended pregnancy; and
- (e) if so, the details thereof, State-wise?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) The role of ASHAs under JSY is as follows:

1. to identify pregnant women who would be benefited by the scheme and facilitate their registration for antenatal check-up (ANC);

2. to assist the pregnant woman in obtaining necessary certifications, wherever necessary;
3. to provide the woman with and/or assist her to receive at least three antenatal check-ups (ANCs) in which she is given Tetanus Toxoid (TT) injections and Iron Folic Acid (IFA) tablets;
4. to identify a functional government health centre or an Accredited Private health institution for referral and delivery;
5. to counsel the woman to opt for institutional delivery;
6. to escort the woman to the predetermined health centre and encourage stay upto 48 hours in the facility with her till she is discharged;
7. to arrange to immunize the newborn till the age of 14 weeks;
8. to inform the Auxiliary Nurse Midwives (ANM)/Medical Officer (MO) about the birth or death of the child or mother;
9. to arrange for a postnatal visit within seven days of the delivery to track the mother's health and make it easier for her to obtain care, wherever necessary; and
10. to counsel the mother to initiate breastfeeding within half an hour to one hour of delivery and continue to exclusively breastfeed till 3-6 months, and promote family planning.

(b) The amount of funds earmarked under JSY since 2005, State-wise, is given in statement-I (See below).

(c) A total of 4.09 crores beneficiaries have been reported under JSY in the last five financially years and year-wise details are given below :

(d) and (e) No, Sir. Estimated numbers of unattended pregnancy are not available with the Government of India.
