

Criterion to determine daily income of BPL families

†1183. SHRI KAPTAN SINGH SOLANKI: Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

- (a) the criterion laid to determine the daily income of BPL families throughout the country;
- (b) whether the daily wages paid by Government to BPL families is insufficient;
- (c) if so, the details of people benefitting by this scheme, State-wise; and
- (d) if not, the details thereof?

THE MINISTER OF HOUSING AND URBAN POVERTY ALLEVIATION (KUMARI SELJA):
(a) Poverty line in the country is determined by the Planning Commission based on the methodology recommended by the Expert Group constituted for this purpose from time to time. As per the Tendulkar Committee Report on Estimation of Poverty, the national poverty line for urban areas at 2004-05 is Rs. 578.80 *per capita* per month.

- (b) Daily minimum wage rate are determined by the respective States/UTs.
- (c) to (d) does not arise.

- (a) the State-wise cities of the country covered under Jawaharlal Nehru Urban Renewal Mission (JNNURM);
- (b) whether Karamsad, the birth place of Sardar Patel, the first Home Minister of India, is included in it;
- (c) the reaction of Centre thereon;
- (d) if so, whether Gujarat Government has made any request to Central Government in this regard, when this request was made; and
- (e) the guidelines of Centre regarding tax collection in the form of user charges under JNNURM?

THE MINISTER OF HOUSING AND URBAN POVERTY ALLEVIATION (KUMARI SELJA):
(a) State-wise details of cities of the country covered under Sub-Mission of Urban Infrastructure and Governance (UIG) and the Basic Services to the Urban Poor (BSUP) components of the Jawaharlal Nehru. National Urban Renewal Mission (JNNURM) are given in the Statement (*See below*).

(b) No, Sir.

(c) and (d) Government of Gujarat requested in July, 2008 to include the city of Karamsad under UIG component of JNNURM being the birth place of Sardar Patel. The request was considered in the 5th meeting of National Steering Group (NSG) held on 05.01.2009. As the number of cities covered under the Mission is to remain around 60 as per guidelines of UIG of JNNURM, the request was not acceded to. At present there are 65 Mission cities and guidelines do not permit further addition.

(e) Collection of user charges is one of the ULBs level reforms to be achieved as per time-line committed in the Memorandum of Agreement (MoA) signed by the State/ULBs.
