## Tenure of doctors in armed forces

1109. SHRI T.M. SELVAGANAPATHI: Will the Minister of DEFENCE be pleased to state:

- (a) the normal tenure of doctors in Army, Navy, Air Force at every level;
- (b) what is the provision to extend the tenure;
- (c) the total number of doctors who have submitted request for extension of tenure during the last two years;
  - (d) how many such requests were agreed to; and
- (e) the details of doctors at every level/rank who were transferred during the last two years and transfer orders which have been cancelled for more than once?

THE MINISTER OF DEFENCE (SHRI A.K. ANTONY): (a) to (e) The normal tenure of doctors in Army, Navy and Air Force, at every level, is as under:—

Rank	Tenure
Lt. General (and equivalent)	6 months — 1☐ years
Major General (and equivalent)	1 — 1☐ years
Brigadier (and equivalent)	1 — 2 years
Colonel (and equivalent)	2-3 years
Lt. Colonel/Major/Captain (and equivalent)	2 - 4 years

Extension of tenure may be granted on organizational requirements and on administrative, medical and compassionate grounds. A total of 167 requests were received for extension of tenure during the last two years, out of which 139 cases have been agreed to and 28 cases have been rejected.

## Agreements of OFs with MNCs for transfer of technology

- (a) whether there is any move of Government to allow the Ordnance Factories (OFs) in the country to enter into agreement with the multinational companies for transfer of technology to meet the demands of all three armed forces of the country;
- (b) whether with present strength of the staff at the Ordnance Factories, it will be possible to meet the demands of the three armed forces;
  - (c) if no, whether Government proposes to recruit more persons for the purpose; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. M.M. PALLAM RAJU): (a) Ordnance Factory Board has been allowed to enter into agreement with Foreign Vendors for Transfer of Technology, in sequel to the Armed Forces procurement, on case to case basis.

- (b) Present Strength of the Staff at the Ordnance Factories are not sufficient to meet the demands of the three Services of the Armed Forces.
  - (c) Yes, Sir.
- (d) During financial year 2010-11, total 14,199 Nos. of staff have been inducted at various levels in Ordnance Factories.

## IDA 59 Jackets for Navy

- (a) whether IDA 59 (Jacket) is used by Navy; if so, what is its weight;
