### Handing over of land to owner after mining

†3142. SHRI SURENDRA LATHI: Will the PRIME MINISTER be pleased to state:

(a) whether Government are considering the formulation and implementation of a policy regarding handing over the land which has been acquired for coal and other mining works to their owners after the completion of mining activities;

(b) if so, by when and if not, the reasons therefor;

(c) whether these people are given compensation and a member of the family whose land is acquired is given employment in coal institutions; and

(d) if so, the details of the land acquired during the last three years along with the details of the landlords given compensation and employment to one of their family member?

THE MINISTER OF STATE IN THE MINISTRY OF COAL (DR. DASARI NARAYAN RAO): (a) and (b) No, Sir. As per Coal Bearing Areas (Acquisition and Development) Act, 1957, it is not permissible to restore land to original owners after coal mining is over.

(c) Compensation is given to the land owners as per the provisions of the Land Acquisition Act, 1894, Coal Bearing Areas (A&D) Act, 1957 or any other State Code. Employment to land oustees is considered as per the provisions of the Resettlement and Rehabilitation Policy of Coal India Limited (CIL).
