Government of Orissa undertaken joint enumeration of trees available on the project site. As per the joint enumeration total 2,90,087 trees as per details given below, were estimated to be available on the project site.

However, recently as a result of Government's efforts, a payment channel has been established and Indian refineries are making payments to NIOC.
