unfunded deficit, to fund the State's annual plan and to implement a special development package in Jungalmahal (Left Wing Extremist affected area).

(d) On an assessment of deficit for the remaining part of the year, and after taking into account the balance borrowings available to the State during the year, support for a more manageable fiscal consolidation path has been envisaged for the State. Project based assistance to the State has also been envisaged for the development of its backward areas, agriculture and allied activities and clean energy initiatives.

Denial of guarantee by ADB to loans given to MFIs

2203. SHRIMATI GUNDU SUDHARANI: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that the Asian Development Bank (ADB) has refused to give guarantee to loans given to Micro Finance Institutions (MFIs) in Andhra Pradesh;
- (b) if so, whether the poor people would suffer ultimately as they do not get loans from MFIs; and
- (c) if so, how the Ministry would look at the issue and ensure that poor people do not suffer and get loan?

- (c) Data regarding economic turnover of sectors of services are not maintained. However, information regarding twenty major sectors of services, based on service tax collected, is provided in statement-II.
