THE MINISTER OF STATE OF THE DEPARTMENT OF DISINVESTMENT (SHRI ARUN SHOURIE): (a) to (c) Disinvestment is a continous process, which was initiated in 1991-92. Govt, considers proposals for disinvestment in several PSEs from time to time. The recommendations of the Disinvestment Commission generally form the basis for the disinvestment plans in specific Public Sector Companies. List of 19 Companies identified for disinvestment (Ministry-wise) is given in the statement (See below):

# Plan for extension of Disinvestment Programmes in North-East

814. SHRI W. ANGOU SINGH: Will the Minister of DISINVESTMENT be pleased to state:

- (a) whether Government have any plan to properly educate regarding the newly taken up disinvestment programme;
  - (b) if not, by when it will be done; and
- (c)-Government's plan for extension of disinvestment programme in the North-East States?

THE MINISTER OF STATE OF THE DEPARTMENT OF DISINVESTMENT (SHRI ARUN SHOURIE): (a) and (b)The disinvestment programme was initiated in the Financial Year 1991-92 and it is not a new programme. The disinvestment policy has been pronounced by the Government from time to time since the 1991-92 budgets through various policy Statements.

- (c) the disinvestment policy of the Govt, has the following sailent features:
- Restructure and revive potentialy viable PSUs;
- Close down PSUs which cannot be revived;
- Bring down Government equity in all non-strategic PSUs to 26% or lower, if necessary; and
  - Fully protect the interests of workers.

The disinvestment policy is applicable to all the PSEs irrespective of their location in any particular region of the country.
