- THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI RAM NAIK):(a)Yes, Sir.
- (b) to (f) Out of the 22 locations recommended for setting up LPG distributorships by the Government of Himachal Pradesh in 1995,11 locations have been found feasible and included in the Marketing Plan. Of thes, e distributorships have already been commissioned at 2 locations and the process is on with the setting up of independent Dealer Selection Board for Himcahal Pradesh for selection of distributors. Out of the remaining U, 10 locations are covered by the extension points and one location is not found feasible for setting up an LPG distributorship in the absence of any motorable road. Details are given in statement (See below)

Out of the 15 locations, recommended by the State Government in 1997,6 locations have been found feasible and included in die Marketing Plan. Of these, distributorships have already been commissioned at 2 locations, Letter of Intent has been issued for 1 location, and die process for selection of distributors is on in respect of 3 locations. So far as remaining 9 locations are concerned, these are covered by the extension points. Details are given in statement-II.
